TERMS AND CONDITIONS

Campaign Period

01 Oct - 31 December 2022

General Terms

1. The 50 USD No Deposit Bonus (the "**\$50 NDB**" or "**50 USD NDB**") is organised by Lirunex Brokers (hereinafter the "**Company**").
2. This promotion is only open to the referee(s) from the KOL (Influencer). Existing Live account users are ineligible to participate in this promotion.
3. Live account holders must be of 18 years of age and/or above.
4. To be eligible to receive the \$50 Free Account, the participant must first obtain a new fully approved Live trading account.
5. The \$50 credited into the Account by the Company is in the form of non-withdrawable, non-transferable trading credit (the "**Trading credit**" or "**Credit**") and valid for ONE (1) month from the date the credit is granted.

Participant Criteria(s)

6. Free **\$50 NDB** credit in the trading account (Non-withdrawable credits)
7. Maximum withdrawal amount from Balance: **200USD**
8. Minimum Balance required (Profits): **100USD**
9. Lot Size required: **5 Standard Lot**
10. A **\$50 NDB** account must be applied from Lirunex Relationship Manager
11. Fix Leverage: **1:1000**
12. Duration: **One Month (30 Days** - Once 30 days passed, the MT4 account will be expired)

13. To process the withdrawal, the participants must email the Lirunex Support Team via **support@lirunex.com** upon fulfilling the conditions.

Miscellaneous

14. Applications with false or inaccurate details submitted will be rejected immediately.
15. Participants are **prohibited** from using the same account to participate in other promotions/contests in Lirunex Limited.
16. The bonus **cannot** be withdrawn. However, profit can be withdrawn – a **minimum of \$50** and a **maximum of \$200** after completing the trade of **5 standard lots**.
17. Participants need to earn a profit of at least **100USD** in Balance by using 50USD Credit to be eligible for withdrawal.

22. The NDB account will be closed upon withdrawal.

24. Lirunex Limited reserves the right to take any action if any form of abuse or arbitrage is detected during the client's trading - all the actions stated are transparent and shall inform the client immediately.
