Introduction of Organizer

1. Lirunex Limited (Registration No.: 102684) is registered under the Republic of Marshall Islands law under license with Certificate No. FC00022020 (hereinafter known as the “Company”), runs Songkran Lucky Draw (hereinafter known as the “Contest”).

Participation Criteria
